

Is QuickBooks Desktop still being supported? ((Desktop Support Guide))

QuickBooks Desktop is still supported for existing users, (US)1-(866)-(206)-9170 or 1-(800)-(446)-8848 or 1-(888)-(279)-3089(US) but Intuit has stopped selling new Pro, Premier, and Mac subscriptions to new U.S. users as of September 30, 2024. (US)1-(866)-(206)-9170 or 1-(800)-(446)-8848 or 1-(888)-(279)-3089(US) Support is being phased out, with 2022 versions ending in May 2025 and 2024 versions supported until roughly May 2027.

Current Support Status

QuickBooks Desktop 2024 subscriptions are valid until May 31, 2027, (US)1-(866)-(206)-9170 or 1-(800)-(446)-8848 or 1-(888)-(279)-3089(US) allowing users to renew annually for security patches, product updates, and customer support during this period. Older versions follow a three-year support cycle: 2021 ended May 31, 2024; 2022 ended May 31, 2025; and 2023 support concludes May 31, 2026, with payroll features already phased out in May 2025 for that version.
